1. Foreword

The discipline and profession of social work is based on academic knowledge as well as practical insights gained from reflection on professional practice, thus contributing to its further development. The reciprocal relationship between theory and practice is important in this context. In other words, social work is both an application-orientated science/discipline related to social problems and challenges, and a theory-driven, self-reflective profession.

The MA work-based degree programme in Social Work in Holzminden is aimed at students who already have a BA degree in Social Work or a comparable degree, and provides advanced specialist knowledge and in-depth specialist knowledge of social work. This includes the ability to analyse professional issues and problems on the basis of current theories and concepts and to develop starting points for the design, review and further development of professional practice. Subject-specific and interdisciplinary action-related competences and qualifications are an important tool for carrying out the tasks involved in social work in a way that is both sensitive to diversity and effective. In addition, students develop and work on their own research questions on the basis of an intensive analysis of various research methods.

The MA work-based degree programme in Social Work is based on the Core Curriculum¹ for Social Work Studies of the German Association of Social Work, the Social Work Qualifications Framework² of the German Association of Social Work and the German-language version of the International Federation of Social Workers' definition of social work used by the German Association of Social Work.

Competences to be taught and acquired:

A) Knowledge and understanding/comprehension

- Comprehensive and broad knowledge and understanding of the academic foundations of social work and of a model field of study, including in-depth knowledge of selected methods of qualitative and quantitative social research
- In-depth knowledge, understanding and ability to apply theories, models and methods of social work in a national and international context in accordance with the current academic discussion
- Overview of current national and international research and development in social work and the ability to independently analyse academic theoretical and methodological principles

Differentiated and in-depth understanding of the theoretical foundations of communication theories, models
and methods in order to systematically address structural exclusion processes and to enable or demand
structural participation opportunities

B) Description, analysis and evaluation

- The ability to independently engage with current academic discussions and to examine the extent to which they are helpful for description and analysis
- The ability to provide technical guidance to colleagues when analysing new, unclear and atypical tasks and to work with them professionally
- The ability to comprehensively and academically analyse internal and external factors/situations that influence each other and to responsibly integrate other specialist disciplines into their own specialist analytical work

C) Planning and conceptualisation of social work

- The knowledge and ability to develop and reflect on complex solution strategies for new, unfamiliar tasks on the
 basis of scientific methodology and current and, in some cases, the latest professional knowledge and research
 findings, and to present these to relevant target groups
- The ability to integrate and implement interprofessional/interdisciplinary research and development processes in planning and concepts
- The ability to design concepts and implement them independently in collegial contexts in a manner tailored to
 the target audience, while being able to communicate the concerns of social work to members of other
 professions in a professional manner

D) Research and enquiry in social work

- The ability to identify relevant information and data, determine their sources and collect them
- The ability to (further) develop research perspectives relevant to social work and to use them for their own research projects and to conduct (practical) research
- The ability to critically analyse and evaluate their own and external research results and information
- The ability to develop innovative research and development methods and strategies based on academic analysis
- The ability to participate in the practical, methodological, academic and theoretical development of the field, to follow it and to advance it through their own contributions

E) Organisation, implementation and evaluation in social work

- The skills and abilities to test and further develop methods in social work and to check their effectiveness
- The ability and skills to set up, support and further develop comprehensive quality management systems based on academic methodology
- Knowledge of relevant academic discourses in other disciplines and critical reflection on the intertwined dependencies and implications of and for social work
- Knowledge of specialist, professional and ethically based decisions in the context of a dynamic, globalised, transcultural world. Students will communicate these in a comprehensible and transparent manner, both to addressees in the professional community and to a broad (professional) public
- Abilities and skills to work actively in discourse and definition processes of social work with people on different hierarchical levels and to develop transcultural relationships and international cooperation through the implementation of networking and cooperative structures

F) General professional skills and approaches in social work

• BA level knowledge and skills

- The ability to effectively lead teams in research and practice from different disciplines and with different levels of training
- The ability to take (sole) responsibility for management and leadership
- The ability to critically reflect on professional actions in relation to societal expectations of the social work profession and (possible) societal consequences, and to develop new options for action for the profession on this basis
- The ability to research and work in national and international contexts with the appropriate linguistic and intercultural knowledge and to apply and utilise methods of empirical social research and to assess their limits and possibilities

G) Personality and approaches

• Stable, resilient, reflective personality with a pronounced empathy for social tasks and the people involved. Students' self-critical and reflective approach will enable them to fulfil a professional, detached occupational role, taking into account their own personality traits and on the basis of a reflective view of the world and people. They will independently define the limits and possibilities of their actions

The MA Social Work work-based degree programme is a 6-semester work-based course with integrated practical components (120 credits). The study programme comprises 9 modules. The degree programme is usually completed in the sixth semester with the master's thesis (plus colloquium).

The distribution of in-person and self-study components within a semester is usually designed with a ratio of 1:2.

Excursions are part of the courses and thus part of the compulsory or elective course and the performance required therein. They are listed and publicised in the seminar schedules. Depending on the module, courses may be held at a location other than the HAWK. They are listed and publicised in the seminar schedules.
